2. Scientific Meetings

Report of YIS 2013

Melissa Gammons reported that the recent Early Career Investigators Symposium on 'Advances in Microcirculation' held at Warwick University on the 13th April, was host to numerous outstanding talks and scientific discussions and showed that there was an exciting future for microcirculation research in the UK. This one day Symposium, also included a workshop "Shaping your career in Vascular Research" led by Dr Andy Salmon which was extremely well received.

The symposium covered topics ranging from angiogenesis to inflammation and vessel permeability, investigating physiological and pathological aspects of the functioning microvessels. Selected oral communications were given by early career investigators ranging from first year PhD students to young post-docs. Not only were the talks well-paced and informative, the scientific questions that followed demonstrated a clear understanding and thirst for knowledge in a seemingly relaxed atmosphere. This was also evident in the poster session where discussions continued and collaborations began to form, the high standard making prize selection a difficult process. Registration costs were kept to a minimum by generous support from the British Heart Foundation, the British Pharmacological Society, the Company of Biologists, the Physiological Society, and the Richard Bright VEGF Research Trust, complementing core support by the BMS and the exhibitors (Moor Instruments and PromoCell). The meeting was a financial success and the organisers could return a profit to the BMS.

Numerous travel grants and prizes were awarded. In total 18 travel grants were awarded to the 46 young investigators that attended, including two international travel grants to attendees from Moscow and Germany. Furthermore, 7 prizes were awarded throughout the day including one for 'Best Abstract '(awarded to Patricia Kelley, University of Ulster).

In a post symposia poll 100% of attendees who took part said there was a need for more Young Investigator events like this one and that it was beneficial to them as researchers. MG, with the approval of the BMS committee asked AGM to consider a biannual YIS event, either stand-alone or preceding annual meetings. BMS will support a YIS and contribute towards the costs of such a symposium.

Report of ESM/EVBO hosted by BMS at IUPS, 2013

Professor Giovanni Mann, President of ESM presented a report on behalf of ESM and EVBO (Organisers: Professor Giovanni Mann and Professor Jeremy Pearson). The report is copied below:

Background

At the 25th ESM meeting held in Paris in 2008, the BMS was selected as the host for the 27th ESM. Shortly afterwards, discussions were held with Jeremy Pearson to consider holding a joint meeting of the 27th ESM and the 7th EVBO meeting at Imperial College in London in July 2013. Both the ESM/BMS and EVBO Committees approved holding a joint meeting at Imperial College in London either before or just after the 37th IUPS Congress in Birmingham, 21-26 July 2013.

During the initial planning of this joint ESM and EVBO meeting, we realised that it would be difficult to secure sponsorship from exhibitors, who would already be committed to the IUPS Congress in Birmingham. Secondly, we were concerned that delegates with interest in microcirculation and vascular biology may not be willing to attend both conferences. Following detailed discussions with Jeremy Pearson (EVBO), I contacted the organisers of the Physiological Society (IUPS Congress) to enquire whether we could integrate our joint ESM-EVBO meeting with the IUPS Congress.

David Eisner, Bridget Lumb and IUPS scientific programme committee were enthusiastic and invited Jeremy and me to join the IUPS scientific programme committee as representatives of ESM and EVBO, respectively. I negotiated very generous financial support (see below) from the Physiological Society and their full support for securing exhibitor sponsorship, handling registrations and abstract submission and online publication.

Selection of ESM-EVBO Symposia at IUPS

On behalf of ESM-EVBO, Jeremy and I sent out a call for symposium proposals to our members, including BMS and other national societies. Each symposium proposal was designed to have 3 established speakers and 2 early career speakers. We received over 50 symposia proposals which were subsequently ranked by an international scientific committee. The top 28 symposia proposals were submitted to the IUPS scientific programme committee, which met in February 2012 to review over 300 symposium proposals. At that meeting, we were able to secure financial support for 18 ESM-EVBO symposia, noting that a total of 102 symposia were selected for the IUPS programme. Moreover, we secured full support for 4 Keynote speakers.

Financial support for ESM-EVBO Symposia and Keynote Speakers

The Physiological Society supported each symposium with £3000 and also waived registrations for the invited speakers, amounting to £54,000 for the 18 symposia and £26,100 for registrations. We also received support for the 4 Keynote speakers, amounting to \sim £10,000.

Thus, joining IUPS has provided BMS with £90,100 to host the ESM meeting. In addition, the BMS was provided with a free exhibitor booth, registrations and abstracts and printing of the programme.

Support for ESM-EVBO Poster Abstract Awards

I contacted national and international microcirculation societies and EVBO to seek their support for poster abstract prizes (£100 each). I obtained the following support: BMS (4), MCS-Microcirculation (5), Japanese (5), Italian (2), Dutch (2), EVBO (5), Karger (2). ESM have supported 4 ESM Travel Awards (£350 each). I then asked all early career investigators to register their interest for these awards and then circulated all relevant abstracts to an international scientific committee who ranked all abstracts on a scale 1 (low) to 5 (high). The assessors were Makoto Suematsu and Mayumi Kajimura (Japan), Sarah George and Jeremy Pearson (EVBO), Marco Rossi (Italian), Angela Shore, Akos Koller and Giovanni Mann (ESM), and Stuart Egginton and Lopa Leach (BMS).

ESM Malpighi Lecture and Reception

The ESM placed a call for nominations for the Malpighi Lecture and an international committee evaluated all nominees and selected Prof Steven S. Segal, who will give his lecture on Wednesday 24 July. His lecture will be followed by a Malpighi Reception kindly sponsored by the BMS and ESM (and SoB).

Profile of BMS and ESM at IUPS

The Physiological Society has provided both BMS and ESM with extensive exposure/marketing at the conference, including full page in programme book, entrance banner, introductory slides with our logos in each theatre, free exhibitor booth for BMS and ESM, logos for ESM and EVBO at footer of each of our 18 symposia in the programme book.

Summary and future ESM Meetings

On a personal note, I feel our "union with EVBO and IUPS" has been successful on several levels. Firstly: a 'competitively' selected scientific programme by an international scientific committee and not just the local organising committee. Secondly: joint meetings provide valuable cross-fertilisation between different societies. Thirdly: organisation and sharing of fund raising is critical in today's economic climate to ensure the continued success of our meetings. Fourthly: high marketing exposure of BMS, ESM and EVBO to delegates worldwide.

Based on my experience with this ESM meeting, it may have been more strategic to involve the BMS committee in some of the 'hands-on' activities, e.g. call for symposia, abstracts, collation of symposium and abstract scores, etc. I would strongly encourage that national microcirculation societies "buy in" to future ESM meetings, e.g. Pisa 2015. By establishing an international Scientifc programme committee, comprised of representatives from each national society, we can underpin scientific and financial support for ESM.

3. Future Meetings

2013. There will be a dedicated Symposium on Microcirculation, sponsored by the BMS at the British Pharmacological Society Meeting this December, 2013.

BMS 2014 at University of Bristol. Andy Salmon presented plans for this meeting. The chosen themes would be Development, Disease and Therapy. The dates: April 10 & 11, 2014. The meeting would be located in two venues at the university which were 90 seconds apart. The second venue would also contain trade exhibits, teas coffees and poster demonstrations. Invited speakers include Professor Sussan Nourshargh (London) and Caroline Savage (GSK). There would be a Trade Workshop where delegates would sign up to see how instruments work at different bays. There could be a Young Investigator Symposium on 9 April which could accommodate 40 to 50 delegates.

BMS 2015. University of Manchester. Dr Andrea Murray was organising this – the theme of the meeting will be **Imaging the Microcirculation**. Venue: Royal Northern College of Music, Manchester. Dates : 16th/17th April 2015

BMS 2016. This will be at Newcastle, organised by Dr Helen Arthur.

BMS 2017. LL was willing to host this in Nottingham. This is also a year where a joint BMS and MCS meeting may be arranged in USA.

Possible venues for BMS 2018 – Leeds, 2019- Sheffield.
