BMS Meetings

Report by BMS 2010 Organiser, Dr Jackie Whatmore (JW)

The BMS 2010/60th Annual Conference (Peninsula College of Medicine and Dentistry, University of Exeter) incorporating the Symposium: **DIABETIC MICROANGIOPATHY** – **OLD PLAYERS AND NEW CONTENDERS** was well attended. JW reported that there were 149 delegates registered with 3 Honorary Members and 9 speakers attending. There were 68 poster presentations and 19 Oral presentations. They were 12 trade exhibitors. Main sponsors of the meeting were the British Heart Foundation, Physiological Society and PromoCell. JW stated that the meeting may generate around £3000 to £4,500 for the Society. Unfortunately, because of the volcanic ash from the Eyjafjallajoekull eruption, flights to and from UK were cancelled which meant that 5 invited speakers, including 1 from Manchester did not come to the meeting. Dr Whatmore and Professor Angela Shore had spent the days preceding successfully organising replacement UK based speakers:

Mechanisms in diabetic retinopathy


Congratulations were given to Dr Whatmore and Professor Shore for all their hard work in organising an excellent meeting.

BMS 2012/62nd Annual Conference (Joint meeting of MCS and BMS)

The meeting will be held at Keble College, University of Oxford Wednesday 4^{th} – Friday 6^{th} July, 2012. Organiser: Professor Chris Garland. The title of the symposium will be **Intra and Inter-Cellular Signalling in the Microcirculation**. The meeting will be a joint one with the Microcirculatory Society (USA) and as such will be of 3 days duration in order to give ample time for free communications (oral and posters) from members of both Societies. Plans are underway to set up a local organising committee and a Joint Scientific Committee. LL will invite MCS formally at their AGM in the Experimental Biology Congress in Anaheim, CA. All student assistance schemes (SAS) will be honoured by each individual Society. Usual BMS prizes and awards will be given.

9th World Congress Microcirculation, Paris, France 26th – 28th September 2010

Plans for the BMS sponsored symposium Consequences of Fetal Programming on Vascular Function in Adulthood the symposium entitled Vascular Imaging in Zebra Fish were progressing well.

In addition, a Young Investigators Symposium (and poster session) on **Recent Advances in Vascular Biology** was also being sponsored by BMS and ESM. Dr Claire Clarkin (Kings) was chosen (after a call to the membership) as the BMS organiser and co-chair of the session. ESM would also identify a co-organiser and co-chair.

The journal Microcirculation wishes to produce a special issue where speakers from chosen World Congress symposia will be invited to submit reviews. "Consequences of Fetal Programming on Vascular Function in Adulthood" was one of the ones chosen.

ESM Meetings

ESM 2011 will be held in Munich, $13^{th} - 16^{th}$ October 2011. Organisers: Ulrich Pohl and Markus Sperandio. There were some concerns expressed about these dates, as they fall in term time for all UK academics.

ESM 2013 will be held in London (28th ESM). Organisers: Professors Giovanni Mann and Jeremy Pearson. The dates and venue for this meeting are still to be decided, but both KCL and Imperial have proven conference facilities.

Terence Ryan Award


LL reported that Professor Terence Ryan had contacted the society about his willingness to continue funding the Terence Ryan awards. Laboratory Visit Grant Awards

2 awards were made: Uzma Reem (University of Sheffield) to visit Dr Zawieja's laboratory in Texas and Melissa Gammons (University of Bristol) to visit the Retinal Research Group in Alcon, Texas USA. Both were awarded £600 each.



Uzma reem was not presenting at AGM. She has already presented a talk entitled "Lipolysaccahride alters the function of rat mesenteric lymphatic vessels" in a free communications session. Melissa Gammons presented a short talk on Analysis and quantification of hypoxia induced intravitreous neovascularisation in flat mounted retinas.

SAS Awards

14 SAS awards out of the 23 applicants were awarded for the 60th Annual Meeting in Exeter. The awardees were also advised that the committee strongly recommend they participate in the Young Investigators Workshop, the extra night funding will be met by BMS.

Early Career Investigator Award

Dr Claire Clarkin (Kings College London) was selected to be the BMS Organisers for the BMS/ESM Young Investigators Symposium entitled **Recent Advances in Vascular Biology** at the 9th World Congress for Microcirculation.

Poster Awards

5. Officers reports

Communication Officer/Membership Secretary's Report (CN)

CN reported that there were 270 members of which 260 were fully paid up.

On behalf of the Society, LL warmly thanked Chris Neal for his excellent service to the society and stated that he would be sorely missed. He was presented with a bottle of his favourite tipple.

AGM approved Professor Jim Middleton as the next Membership Secretary.

Proceedings Editors Report (NK)

Neena Kalia reported that all abstracts would be sent to Microcirculation within 2 weeks of the end of meeting. The stand-in speakers were invited to send their abstracts to NK if they wished them to be published. The publication of the abstracts would be free.

Honorary Treasurer's Report (precirculated) (ZB)

ZB, presented her report. She alerted AGM that the increased costs for membership of ESM paid by the Society (4K biannually), advances for the 2011 and 2012 meetings and the increases in the number of prizes given by the Society meant that membership fees would have to be increased. AGM were asked to consider a proposed increase in annual subscription for members (£50, £45 or £40) and student members (£20 or £15). AGM agreed to £40 being the annual subscription fee for full members paying by direct debit (£44 by cheque). The fees for student members would be £15.

ZB was looking at fees being paid as a "Gift Aid" as this would have favourable tax implications. Moreover she was looking at methods of online payment (PayPal) arrangements.

ZB also announced that she was stepping down as Treasurer in the autumn term to continue with her studies and that the Society would need to find a new Treasurer by then and certainly by the next AGM. LL to email membership for nominations.

AGM was advised that the website was being re-designed by Daniel Fraser. The new look had been approved by the BMS committee. Set up and design of this would cost the Society £1000, with regular updates costing £100 per year.
